Minutes, Monday Morning

July 1,2024

First Day, First Session.

Ritualist Opening Occasional Chapter:

The occasional chapter was opened by the host jurisdiction (BA.), at 8:30am, Deputy Grand High Priest Sylvanus Bethel Presiding, who then declared the occasional chapter open. The Most Excellent Grand High Priest, Lorne Basden was received and escorted to the east, and given grand honors and was presented the gavel at 8:45am. Grand High Priest Loren Basden asked that G.C.G.C. Grand King, Stephen M. Copher, Jr. (MI), be admitted, and the King said he wanted to come in with the other Grand Conference Officers. After Noon Session, July. 1,2024

1:25pm. Opened with the Pledge Allegiance to the flag of the United States of America, and the singing of the Bahama National Anthem by the body. The principal Sojourner then blessed us with prayer.

GENERAL GRAND HIGH PRIEST ADDRESS:

The General Conference Grand High Priest, Nathaniel Degraffinreaidt talked about keeping with the changes, upgrades, and progressions of this General Grand Chapter, this is how G.G.H.P. Degraffinreidt Began His Allocution. He then requests prayer from the principal Sojourner. He stated that he has had numerous opportunities to serve this grand body through his travels and visitations being the face of the General Grand chapter he expressed thanks to all other companions and brothers for their participation in all their works. General Grand High Priest Degraffenried noted that many jurisdictions are being proactive in their missions of uplifting the several causes of Holy Royal arch masonry, namely support of the youth, awarding scholarships, feeding the homeless, working with the sisters, and many more. He

expressed to the jurisdiction of Kentucky, appreciation for their hosting of the general conference last year with special thanks given to then grand high priest and current medical advisor companion Arlander Reddick.

General Grand High Priest Degraffinreaidt outline his travels, noting that all of them were done at no cost to the General Grand Conference. All Jurisdictional Grand High priests were thanked for their recognition and hospitality shown to him and his officers upon their several visits. He noted his constitutional duty to step up and preside over the General Grand Conference, when in December 4/2023 he received word that his predecessor was no longer eligible to do so. General Grand High Priest spoke about the Heroines of Jericho voting to not attend in the Bahamas emphasizing that they violated their constitution namely Article 4 Section 1 and article 12 Section 1 saying in part that the Heroines of Jericho will meet annually at the same time and place as this General Grand Conference. General Grand High Priest Degraffenreidt continued to summarize the events surrounding the situation, as well as the high amount of negativity that came with it. He summarized his community service and encouraged us to pray for our youth and named states that have been hit with natural disaster.

- (4) To recognize Alaska as a member of this General Grand Conference.

The committee rejected this recommendation on account of the statement about the loan.
- (2) To research obtaining a business credit card to help our business become more efficient if feasible. The committee rejected this recommendation.
- (3) For us to work to get our HOJ back in perspective with us. The committee rejects this recommendation and suggests that the jurisdictional Grand High Priests hold their respective Grand Courts accountable to their constitution.
- (4) To recognize Alaska as a member of this General Grand Conference. The committee recommends deferring this matter until such time as specific prerequisites have been satisfied with regard to the jurisdiction of Oklahoma.

Moved by, PGHP Patrick Brathwaite (TX), second by, PGEGM Russell Duckett (NY) motion Carried with one opposition from Dr. Shawn Willis (OK), wanted clarification on Alaska.
