Frequently Asked Questions for the MWGM's Testimonial Celebration

1. How do I purchase tickets?

Department Heads should complete the Ticket Order Form and submit it to the ticket administrators at <u>mwugl.events@gmail.com</u>.

For everyone else, the preferred ticket purchase method is to visit SimpleTix <u>https://mwugloffl.simpletix.com/e/175490</u>.

- Select the event and choose the number and type of tickets you want.
- Click "Add to Cart" and proceed to checkout.
- Fill in your payment information and complete the purchase.

Those unable to use the website can contact the ticket administrators at <u>mwugl.events@gmail.com</u> or you may use the Ticket Order Form.

2. Can I pay my Lodge Secretary for my tickets?

Tickets purchases are not complete unless purchased through SimpleTix or by using the Ticket Order Form. Seats will not be held until payment is received by the ticket administrators. Payments made to your Lodge Secretary does not constitute a completed ticket purchase. If you wish, you can coordinate the purchase of seats through your Secretary, but he/she must either use SimpleTix or he/she must remit the Ticket Order Form and payment to the ticket administrators.

3. What's the difference between the two types of tickets available for purchase?

The first ticket type is for individual ticket purchases. There will be no assigned seating for these tickets. Attendees may sit at any open-seating table not marked "Reserved."

The second ticket type is for table purchases (for up to 10 attendees per table). While having the names of all attendees in your party at time of purchase is not required, it is recommended that at some point, you enter the names of the individuals that will be seated at your table. Names and other information can be added at any time after purchase.

4. Is there a limit to the number of tickets I can buy?

No, there are no limits to the number of tickets or tables you can purchase, however, large purchases may take several transactions.

5. If I purchase a table and individual tickets, will my entire group be able to sit together?

No, please remember that only "table" purchase ticket holders are guaranteed to sit together. For example, if you have 25 attendees, and you purchase two tables and five individual tickets, it will be up to the purchaser to decide which of the 25 attendees will sit at the two "Reserved" tables. The remaining five guests must find seats at open-seating tables not marked "Reserved."

6. What payment methods are accepted on SimpleTix?

We accept major credit cards, including Visa, MasterCard, American Express, and Discover.

7. What is the fee for SimpleTix, and is there a fee if I fill out the Ticket Order Form and send a check?

The fee shown online and on the Ticket Order Form is a processing fee required to cover the administrative costs associated with your ticket purchase. This fee is required regardless of how you purchase your ticket, i.e., online or by mailing in the Ticket Order Form.

8. Are purchases refundable?

No. Purchases are nonrefundable.

9. How will I receive my tickets?

After your purchase, you will receive a confirmation email with your electronic/print at home tickets attached. You can print the tickets or show the digital version on your smartphone at the event. All tickets will be scanned and validated for entrance. Please do not re-issue a ticket that you have already assigned to a guest. Once a ticket is validated it cannot be used again. Guests with used tickets will be redirected to the onsite ticket administrators to purchase a ticket, if available.

10. What should I do if I haven't received my tickets?

First, check your spam or junk email folder. If you still can't find your tickets, contact our customer service/ticket administrators at mwugl.events@gmail.com.

11. Can my spouse/friend who is not in the Order attend this event?

Yes. This event is open to the public. Spouses and friends are invited to attend with a paid ticket.

12. How can I guarantee that my group sits together if I do not purchase a table?

Unfortunately, there is no way to guarantee that your group will sit together if you do not purchase a table. If you do not purchase a table, we encourage your group to arrive early for the best chance of finding an open-seating table for your group.

13. Will I be able to hold seats at an open-seating table for my guests who are arriving later?

NO! Your group will need to arrive together for the best opportunity to secure an open-seating table that seats all the guests in your party at the same table.

14. Can I buy tickets at the door?

Possibly, depending on availability. This event is expected to sell out quickly, and no additional ticket inventory will be added once tickets are sold out.

15. Can I transfer my ticket to someone else?

Yes. Open the email confirmation with the tickets attached and update the attendee's information.

16. What if I lose my email or electronic ticket before the event?

A reminder email with your electronic ticket will be sent 24 hours before the event. For all other questions or concerns, please contact the ticket administrators at mwugl.events@gmail.com.

17. Will tickets be scanned/collected at the door?
